

# STORE & INSURE - TERMS OF BUSINESS

If you are a customer classified "consumer" (i.e. where you are acting for purposes outside of your trade, business or profession) you have the right to cancel your policy within 14 days of receiving your Policy documentation. If you decide to cancel your insurance contract within this timeframe and the Policy has not incepted and/or you have not made a claim on the policy, you will receive a refund of any premium paid, less any commission or fee to cover our administration costs.

## Confidentiality

Any information in our possession relating to you or your business is confidential. However, it will be necessary to disclose information which is material to the risk being insured to insurers. Any sensitive information will be handled appropriately. Under the terms of the Data Protection Act 1998, you are entitled to see any personal information that we hold on our records. All activities undertaken by us are for your exclusive use and all reports, recommendations, proposals, data or other information provided by us are for your sole use and you agree not to divulge such information to a third party without our written permission.

### Law and Jurisdiction

These terms of business shall be governed and construed in accordance with English Law. In relation to any legal action or proceedings arising out of these terms of business both parties irrevocably submit to the jurisdiction of the courts of England and Wales.

## Duty of Disclosure

Any information provided to us by you or to your Insurer is your responsibility and must be full and complete. Any failure to make such a full and complete disclosure or you fail to declare a relevant fact material to the insurance may lead to a claim not being paid by your insurer and cover could be invalidated.

## Insurers

It is our normal practice to assess on a regular basis the financial strength of the financial institutions that we introduce to our clients. This process involves monitoring the financial ratings applied by independent rating agencies such as Standard & Poor's and Moody's along with other publicly available information.

The ratings applied to each firm are a reflection of the agencies' views on the medium to long-term ability of each firm to meet its obligations to its policyholder. Where an insurer achieves or exceeds our minimum requirements we place it on our acceptable list. It should be noted that whilst we take every care to promote only the strongest institutions, we are unable to guarantee the financial strength of any insurance company.
